Fight IQ Global notice: Please read this document carefully. It explains important information about app data, subscriptions, advertising-supported features, account deletion, and safety-related disclaimers for combat-sports use.

1. Acceptance of these terms

These Terms of Use (the "Terms") govern your access to and use of the Fight IQ Global mobile application, website, and related services (collectively, the "Services"). By downloading the app, creating an account, or using the Services, you agree to be bound by these Terms. If you do not agree, do not use the Services.

2. Eligibility and accounts

You must be legally capable of entering into a binding agreement to use the Services. If you are under the age of majority where you live, you may use the Services only with any consent or supervision required by applicable law.

You are responsible for providing accurate account information, maintaining the confidentiality of your credentials, and all activities that occur under your account. You must promptly notify us of any unauthorized use or security issue affecting your account.

3. Description of the services

Fight IQ Global provides combat-sports related tools and features that may include fighter and opponent data entry, strategy support, fight-camp planning, drilling plans, sparring plans, video analysis, AI-generated content, downloadable reports, avatar/profile features, advertising-supported access, and premium subscription access. We may modify, suspend, or discontinue features at any time.

4. Advertising-supported features

Fight IQ Global may display advertisements in free, trial, or ad-supported versions of the Services. Ads may be delivered by us or by third-party advertising networks, mediation platforms, or measurement providers.

Advertisements may link to third-party websites, apps, products, or services. We are not responsible for third-party advertiser content, claims, products, services, websites, or privacy practices. Displaying an ad does not mean Fight IQ Global endorses the advertiser or advertised product.

Deleting your Fight IQ Global account or deleting the app does not automatically cancel your subscription.

7. No guarantee of results

8. User content and permissions

You may submit or upload content such as names, athlete data, text, notes, prompts, photos, documents, and videos ("User Content"). You retain ownership of your User Content, subject to the rights you grant to us in these Terms.

- impersonate another person or misrepresent your affiliation;

- reverse engineer, scrape, copy, or misuse the Services except as allowed by law;
- manipulate, exploit, or interfere with advertising, billing, entitlement, or measurement systems;
